Attendance Estimate: 20

Dates We will run both days to test out maximum flexibility approach for big matches. There is one limitation and one complication because of this format which makes preregistration more critical for this match. I must have preregistrations of 5 or more for each day by Friday so that I can notify everyone if a day must be canceled. I also must have EIC/DR registrations for the same reasons and to avoid the challenge of trying to refund Saturday fees if Sunday does not have enough more shooters to satisfy the required minimums. While I always understand and will respect if there is equipment failure or other inability to shoot a match that you sign up for, please try to be accurate in your registrations.

Limitation, We will run both days as long as there are 5 or more shooters each day, I cannot use the club resources if we only have a tiny number of shooters on a day, I chose 5 as the minimum number.

Complication, The EIC and DR matches will be combined over the 2 days therefore it is possible that we won't know if there will be any leg points on Saturday because we don't get a minimum number of shooters from the combined 2 days. I will make every effort to avoid that, but if it happens, It will be difficult to track down everyone that paid on Saturday to refund their fees so I may miss

Targets: NRA Slow Fire (B-6) at 50 yards. NRA Timed and Rapid Fire (B-8), turning targets at 25 yards.

Limit: One Relay of 25 shooters per day.

Rules: Current NRA Precision Pistol & CMP Rules shall apply.

<u>Classifications:</u> The NRA Classification System will apply. Competitors will be required to show proof of

classification, or be subject to an assigned classification by the Statistical Officer.

Minimum Class/Category: There will be no minimum classifications or categories.

Refires: The Alibi Rule will be in effect.

<u>Challenges:</u> A \$10.00 fee will be assessed for all unsuccessful challenges. All challenges will close one hour after the end of Match 24 each day.

Teams: All teams will be four shooter teams; pickup teams are not allowed. Four shooter teams must comply with

Rules 2.10 - 2.20.

<u>Distinguished Revolver Match:</u> Relays may be fired BOTH days. Current NRA Rules shall apply. Revolvers WILL be checked for compliance with the rules. **DR and CMP shooters may fire on the same relays.**

<u>CMP "Service Pistol", Service Revolver" & ".22 Rimfire" Matches:</u> Relays may be fired BOTH days, and will begin after the .45 cal. Match #16, or about 3:30 PM. The match will be conducted in accordance with current CMP Rules. The CMP "Eligibility Affidavit & Liability Agreement," is required to compete. If Tri-County Gun Club does not have your form on file, then you must present it at time of entry. All competitors must certify their eligibility by signing the entry and score card. An entry fee of \$15.00 for EIC match must be paid in cash by all competitors.

EIC match Arms and Ammunition: Eligible arms are defined by CMP PISTOL COMPETITION RULES publication 27th edition, Rules 4.1.x and 4.2.x. Eligible ammunition is defined by CMP PISTOL COMPETITION RULES publication 27th edition, Rules 4.4.x. Competitors supply their own ammunition.

CMP, DR, and Harry Reeves shooters may fire on the same relays.

AWARDS: There will be no set award schedule.

FOOD & BEVERAGES: There will be a **30 minute** Lunch Period to help shorten the total match time, please be sure to bring lunch with you.

ENTRIES: Advance entries are required for reserved positions. DO NOT send advance payment; but pay at the time of registration.
