FEES: An entry fee of \$30.00 will be charged for the full 2700. Those firing 2 of the three matches will be charged \$25, 1 match \$20. There will be no charge for juniors for the 2700 only. CMP Excellence in Competition matches are \$20 per match for those shooting the 1800 and \$30 for “walk-in” shooters.

SQUADDING: First come, first served up to 15 shooters per day. For EIC matches only, relays will be run as needed to accommodate all shooters.

SCORING: Scoring will be by competitors in teams of two after each stage (10 shots).

CLASSIFICATION: The NRA classification system will be used. Competitors without a valid classification card or Score Record Book will compete in the master class.

Classes: Separate class awards will be given.

1. If a class has less than 2 competitors, that class will be combined with the next higher class.
2. No class will be combined into the master class.
3. If any class, including the master class consists of less than five competitors, awards will be given only for the aggregate Matches.
4. No class will be moved up more than one class.

TIME: 8:30 AM. Only 1 relay of 15 shooters can be accommodated due to time and space. Priority will be given to those firing the full 2700. NRA membership is not required.
