Match 2	National Match Course, 10 shots each slow, timed and rapid fire
Match 3	Timed fire, four strings of 5 shots in 20 seconds
Match 4	Rapid fire, four strings of 5 shots in 10 seconds
Match 5	Aggregate

**High Master/Master = 4 points**

**Experts = 3 points**

**Sharpshooters = 2 points**

**Marksman = 1 point**
